The Council of the Synod of the Mid-Atlantic approved the proceeds from the sale of a campus ministries building on Alexander Avenue in Durham Avenue, North Carolina to be used to establish a Visionary Fund for committees of Synod. The principal of the Fund must be protected and maintained as a permanent program grant fund; and that the interest earned be accumulated in a separate income fund for program grants and disbursed by the Council according to the set guidelines

The Council approved the use of this fund for ministries to define a specific need and plan that will clearly lead to the objective of new, existing, racially inclusive and creative programs which address ways to implement the priorities of Synod in the areas of **education, evangelism and social justice**. Presbyteries are welcomed to propose projects in these areas.

We continue to encourage ministries to seek funding directly from the presbyteries of the Synod of the Mid-Atlantic.
